AN ORDINANCE AUTHORIZING EXECUTION OF MUNICIPAL AND COST APPORTIONMENT SUPPLEMENTAL AGREEMENT NO. 1 WITH THE MISSOURI HIGHWAYS AND TRANSPORTATION COMMISSION FOR THE US 24 HIGHWAY BRIDGE REPLACEMENT PROJECT; AUTHORIZING THE CITY MANAGER TO APPROVE MINOR AMENDMENTS TO THE AGREEMENT; AND MAKING THE NECESSARY APPROPRIATIONS.

WHEREAS, the City Council of the City of Independence, Missouri, is desirous to cooperate with the Municipal and Cost Apportionment Supplemental Agreement No. 1 presented by the Missouri Highways and Transportation Commission for the US 24 Highway Bridge Replacement Project; and,

WHEREAS, the City Council of the City of Independence, Missouri, did approve Ordinance No. 18947 authorizing the City Manager to execute a Municipal and Cost Apportionment Agreement with the Missouri Highways and Transportation Commission on November 5, 2018;

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF INDEPENDENCE, MISSOURI, AS FOLLOWS:

SECTION 1. That the City Manager of the City of Independence, Missouri, is hereby authorized and directed to execute for and on behalf of said City a certain Municipal and Cost Apportionment Supplemental Agreement No. 1 with the Missouri Highways and Transportation Commission for the US 24 Highway Bridge Replacement Project; a copy of which is attached hereto, incorporated by reference thereto and made a part hereof as though fully set out herein.

SECTION 2. That the City Manager is further authorized to approve such future change orders or amendments to the agreement as may be necessary to complete the project without Council approval, as long as the total of all such change orders does not exceed Thirty Thousand and NO/100 Dollars (\$30,000.00), the funds necessary for said change orders or amendments are in fact available and provided a copy of each change order or amendment is approved by the City Manager, is identified as being authorized by this ordinance and is filed with the City Clerk.

SECTION 3. That appropriations are hereby increased in the Street Sales Tax by Three Hundred Thirty Thousand and NO/100 Dollars (\$330,000.00) for the US 24 Highway Bridge Replacement Project from the undesignated Street Sales Tax fund balance.
